Emerita Distinguished Professor Ruth Wodak, Ph.D., Dr. habil., Dr. h.c., FAcSS, was born in London, 12 July 1950. She was *Distinguished Professor and Chair of Discourse Studies*, Lancaster University (2007-2014), *Professor and Chair of Discourse Studies*, Lancaster University (2004-2007), *Research Professor*, Austrian Academy of Sciences, Vienna (1999-2002), *Full Professor of Applied Linguistics*, University of Vienna (1991-2004). She continues to be affiliated to Lancaster University (as PhD supervisor) and University of Vienna. She was PI of the FWF funded project "The Discursive Construction of National Identity-2015" (2015-2017).

**Research Interests** include theory and methods of discourse studies; identity politics and politics of the past; language and/in politics; prejudice and discrimination; far-right populism; gender studies.

**Publications** in German, English and French (H-Index 100): 10 monographs, ca 85 co-authored and edited books as well as special issues, and over 420 peer-reviewed articles and book chapters. Her most recent monograph *The Politics of Fear. What Right-wing Populist Discourses Mean* (Sage, 2015) has been translated into German (2016), Japanese (2019), Russian (2019) and is currently being translated into Bosnian and Farsi. The second revised and extended edition will be published 2020. She received the Austrian scientific book prize (Social Sciences) for the German version in 2017. *Translations* of publications into Arabic, Bosnian, Chinese, Hebrew, French, Japanese, Italian, Polish, Portuguese, Russian, Slovene, and Spanish.

**She is (co-)editor** of *The Journal of Language and Politics; Discourse & Society;* and *Critical Discourse Studies*.

Selected Visiting Professorships, amongst others, at Georgetown University, Washington, DC (USA) as Davis Chair for Interdisciplinary Studies (2014), Örebro University, Sweden, as Kerstin Hesselgren Visiting Chair of the Swedish Parliament (in 2008), Permanent Fellow at Collegium Budapest from 2002-2004, and Austrian Chair, Stanford University (1992-1993). 2016, she spent 3 months as Senior Schuman Fellow at the EUI, in 2017 she was awarded the Willi Brandt Chair at Malmö University. Currently, she is a senior fellow at the Institute for Human Sciences in Vienna (2020).
